**AN ORDINANCE ADOPTING AND APPROVING SALARY AND WAGES FOR
CERTAIN ELECTED OFFICERS, APPOINTED OFFICERS AND EMPLOYEES OF
THE CITY OF KAHOKA, MISSOURI**

**BE IT ORDAINED BY THE BOARD OF ALDERMAN OF THE CITY OF KAHOKA, AS
FOLLOWS:**

SECTION 1: The Board of Alderman for the City of Kahoka, being fully advised in the premises and pursuant to the terms of Missouri Revised Statutes Section 79.270 do hereby set and affix the salaries, wages and compensation for the following named officers, both elected and appointed, as well as the following named employees for the City of Kahoka for the fiscal year beginning April 1, 2017 and ending March 31, 2018 herein as follows to-wit:

GENERAL FUND

City Attorney \$1,500.00 per month

Fire Chief \$250.00 per month

CEMETERY

Cemetery Sexton (John Hume) \$3,060.00 per year

ANIMAL CONTROL

Dog Catcher (Bill Young) \$9.52 per hour plus an extra \$5.00 per animal

CITY POOL

Manager \$4,500.00 per season

Assistant Manager \$9.00 per hour

Returning Lifeguards \$8.00 per hour

Lifeguards \$7.70 per hour

CITY STREET

Street Supervisor (Ron Bourgeois) \$14.07 per hour

Laborer (Kirk Huckey) \$12.92 per hour

CITY WATER AND SEWER

Water Generation Supervisor (Jim Alderton) \$13.92 per hour

Water Distribution Supervisor (Kevin Yates) \$17.33 per hour

Laborer (David Edmondson) \$15.50 per hour

Laborer (Bill Irvin) \$11.79 per hour

Office (Lori Hogan) \$10.29 per hour

CITY ELECTRIC

Program Manager (John Williams) \$17.80 per hour

Laborer (George LeMaster III) \$13.62 per hour

Laborer (Luke Sedore) \$11.03 per hour

Electric Distribution Designer (Chuck Kerner) \$25.00 per hour with a minimum of 8 hours per month

CITY CABLE

Laborer (Jeremiah Sherrill) \$12.45 per hour

In addition to the compensation set out herein the employees are further authorized additional compensation for vacation time, for (4) hours per month sick leave, 457 (four hundred fifty seven) retirement plan, medical and dental insurance coverage and family pool passes.

CITY CLERK salary \$30,927.00 per year based on a minimum of thirty-seven and one-half (37.5) hour work week and additional time which may be required by the Mayor or the Board of Aldermen with no overtime, plus \$50.00 for each council meeting and KCDI meeting attended.

In addition to the compensation set out herein the City Clerk is further authorized vacation time, four (4) hours per month sick leave, 457 (four hundred fifty seven) retirement plan, medical and dental insurance coverage and family pool passes.

CITY TREASURER salary \$21,918.00 per year based on a minimum of thirty-seven on the one-half (37.5) hour work week and additional time which may be required by the Mayor or Board of Aldermen with no overtime.

In addition to the compensation set out herein the City Treasurer is further authorized vacation time, four (4) hours per month sick leave, 457 (four hundred fifty seven) retirement plan, medical and dental insurance coverage and family pool passes.

POLICE DEPARTMENT

Chief of Police \$35,000.00 per year payable every two weeks

Chief Deputy \$32,000.00 per year payable every two weeks

Part time Police officers \$9.25 per hour payable every two weeks for ninety (90) day probation period increasing to \$9.50 per hour payable every two weeks after probation period effective upon hiring date, hours to be fixed by the Police Board and Chief of Police; in addition to the

compensation set out herein the part time Police officers are further authorized additional compensation for uniform allowance to be fixed by the Police Board and Chief of Police.

SECTION 2: The Mayor and Board of Alderman may authorize additional compensation in the form of overtime payments, vacation time, sick leave, 457 retirement plan, medical and dental insurance coverage for only employees of the City and not Officers of the City, which have not been specifically set out herein, from time to time.

SECTION 3: This Ordinance shall be in full force and effect on April 1, 2017 after its passage and approval.
